Mexico Trip Agreement

This agreement is the complete and entire agreement between CrossRoads Missions, 3231 Ruckriegel Pkwy, Suite 111, Louisville, KY 40299 and _____.

Regardless of the place of signing of this agreement, the "Client" agrees that for purposes of venue, this agreement was entered into Jefferson County, Kentucky, and any dispute will be litigated or arbitrated in Louisville, Kentucky, and the "Client" hereby consents to the personal jurisdiction of the Kentucky State Courts (or in the county, city and state of CrossRoads Missions current address at the date of such litigation). Furthermore, the "Client" waives any right to or claim of sovereign immunity. This agreement shall be enforced effective with the acceptance by CrossRoads Missions.

Fees

All fees within this agreement are in United States funds. Adhere to dates below unless otherwise agreed upon with the Field Coordinator. Once spaces are held by a deposit they are no longer available for other groups or individuals to reserve. Therefore, all deposits are non-refundable or non-transferable to another field.

NO SPOTS ARE SECURED UNTIL DEPOSIT HAS BEEN RECEIVED

The \$500.00 per participant fee covers supplies for home construction and renovations, facility repairs and renovations and all housing, food and supplies for worship and devotions. This DOES NOT include transportation costs from San Antonio, travel meals or the meal at the Market. Transportation to and from San Antonio is an additional \$50.00 per person. The initial deposit is \$100 per person. Trip spots cannot be guaranteed until the deposit has been received. Deposits are non-refundable and non-transferable to another field. For example: if your deposit is for 30 trip participants and you end up having only 28, the deposit is still based upon your original 30 participants.

The first payment, in the amount of \$200.00 per person is due by February 15th for spring trips and March 1st for summer trips. Other payment dates (for non spring/summer dates) (2nd payment due date) _____ (Date of actual trip _____ if applicable). Missing any payment date may result in late payment penalties equal to five percent of the **total trip amount**.

For example: # of Trip Participants: 40
Cost per Participant: \$500.00
Total Trip Amount: \$20,000.00
Penalty Rate: 5%
Penalty Amount: \$1000.00
Total Amount with Penalty: \$21,000.00

A final payment of \$200.00 or \$250.00 per person or full remaining balance is due on March 1st for spring trips and May 1st for summer trips. Other payment dates (for non spring/summer dates) (3rd payment due date) _____

Changes

All changes must be approved by CrossRoads Missions Mexico Field Coordinator. Change requests must be made in writing. (These requests may be submitted via e-mail or fax) CrossRoads Missions is available to assist your group with travel arrangements, however, all travel expenses are the responsibility of your trip group.

General Agreement Terms

All deposits and payments to CrossRoads Missions are non-refundable and non-transferable to another field. CrossRoads Missions, at their discretion, will provide a credit towards future available trips, rather than a refund of such funds.
